Description:

1. At index 126-06, in the LH106 HAZMAT - English Measurement Code, DE 355, add the code values '2R - Kilocurie', '4D - Curie', 'G2 - U.S. Gallons per Minute', 'M5 - Microcurie', 'MU - Millicurie', and 'PN - Pounds Net' and remove the code value 'H4 - Hectoliter'. Modify the ELEMENT CONDITION note to read: Required if LH107 is used. At least one LH106/LH107 or LFH05/LFH06 are required to pass the HAZMAT unit of measure and quantity. If an English and Metric unit of measure are available, both are required.
2. At index 131-05, in the LFH05 - HAZMAT - Metric Measurement Code, DE 355, modify the code list referenced in Section 6 to add the code 'H4 - Hectoliter' and remove the codes '2R - Kilocurie', '40 - Curie' (note: this code value is incorrect in the current version of the DTEB IC; the correct value for Curie is '4D' by ASC X12 standards), 'G2 - U.S. Gallons per Minute', 'GA - Gallon', 'M5 - Microcurie', 'MU - Millicurie', and 'PN - Pounds Net'.

3. At index 131-06 modify the ELEMENT CONDITION note to read: Required if LFH05 is used. At least one LH106/LH107 or LFH05/LFH06 are required to pass the HAZMAT unit of measure and quantity. If an English and Metric unit of measure are available, both are required.
