There are disconnects between the Schedule D/K Census and DOD Water Port Codes. The census codes are not as granular as the Water Port Codes used by the DOD. There are also examples of missing codes for ports the DOD uses. Adding the option to send the DOD Water Port Codes would help resolve booking/payment issues with the carriers. It would also Alleviate the need to employ complicated translations, which are at best a guess.
