At indices 83-09 and 140-09, L009 - Type Pack Code change D0D Recommended Attributes from 'C' (conditional) to 'M' (mandatroy). Add code value 'PCK - Packed - not otherwise specified'. Change element usage note from: "Do not use for air manifests or HL loops subordinate to Pallet Header Information loops (HL03 contains '24'). Select appropriate three-position Type Pack Code value to represent type code that describes the Type Pack for the Shipment Unit." to read "For air manifests or HL loops subordinate to Pallet Header Information loops (HL03 contains '24') use

code 'PCK' to meet X12 syntax compliance requirements. Otherwise select the appropriate three-position Type Pack Code value that describes the Type Pack for the Shipment Unit."
