At index 3-01, update language as follows:

Reference Identification Qualifier

Reference Section 6 for the list of valid qualifiers and usage.

Add the following Reference Identification Qualifiers for index 3-01 of the N9 Segment to Section 6:

18 - Plan Number

Use '18' to denote Transportation Tracking Number.

3L – Branch Identifier

Use '3L' to denote MILSTAMP aerial port code for the location reported in the B411 at index [2-11].

4L - Location-specific Services Reference Number

Use '4L' to denote the International Civil Aviation Organization (i.e. ICAO) code of the location reported in the B411 at index [2-11] for events occurring at an airport.

5D – Line of Credit Category

Use '5D' to denote the Schedule D Census code for the location reported in the B411 at index [2-11] when the MILSTAMP water port code is not available.

5K – Commercial Driver's License

Use '5K' to denote Schedule K Census code for the location reported in the B411 at index [2-11] when the MILSTAMP water port code is not available.

8X - Transaction Category or Type

Use '8X' to denote Delete Transaction.

BL - Government Bill of Lading

BM - Bill of Lading Number

BN - Booking Number

Use 'BN' to denote Booking Number. The value passed in the N902 cannot exceed 16 character in length.

CR – Customer Reference Number

Use 'CR' to denote the Consignee DODAAC for the location reported in the B411 at index [2-11].

CT - Contract Number

DO – Delivery Order Number

Use 'DO' to denote the Consignor DODAAC for the location reported in the B411 at index [2-11].

EQ - Equipment Number

FI - File Identifier

Use 'FI' to denote Port Call File Number (PCFN). When used, the value passed in the N902 must be exactly 6 characters in length.

JX - Prior Postal Zip Code

Use 'JX' to denote the Postal Zip Code for the location reported in the B411 at index [2-11] when no other location code for the event location is available (e.g. DODAAC, Census Code,

MILSTAMP code, or ICAO code).

P4 - Project Code

Use 'P4' to denote Status on Containers Directly Booked with Shipper.

PG - Product Group

Use 'PG' to denote MILSTAMP Surface Commodity Code. The DoD community expects the most up to date commodity code available from the carrier community and not just an echo of the commodity code from the 300 transaction set.

SN - Seal Number

TG - Transportation Control Number (TCN)

Use 'TG' to denote Transportation Control Number (TCN). The value passed in the N902 must be exactly 17 characters in length.

TT - Terminal Code

Use 'TT' to denote the MILSTAMP water port code of the location reported in the B411 at index [2-11].

ZZ - Mutually Defined

Use 'ZZ' to denote DoD Voyage Document Number. The value passed in the N902 must be exactly 5 characters in length.

Adds qualifiers for association to the location in the B411.

When identifying locations for B4 shipment statuses, in the B403 at index [2-03], the carriers currently provide the event location in a free form text field in the B411 at index [2-11]. Free form text locations are problematic because they're subject to data quality issues. All other event locations in Defense Transportation Systems (i.e. DOD systems) are identified by location codes vs. free form text fields, so integration of free form text locations in the 315A with event location data received from those DOD systems that use codes causes numerous problems. Since the B4 segment does not provide a place for reporting event location code information, adding the location qualifier and code to the N9 allows for association with the event location transmitted in free text form in the B411 at index [2-11]. This will alleviate data quality issues and also improve ITV needed for end users of the data.
