FEMA (through DLA) has requested the addition of these four changes.

In support of a DLA-FEMA EDI project, DLA carriers must implement the DTEB 214F – Federal and DOD transaction. The project go-live is April 2019, and is a joint effort between DLA and FEMA, with help from USTRANSCOM J6. The goal of the project for DLA to provide DTEB 856F Advance Ship Notices (ASNs) to FEMA during disaster relief operations. FEMA will use this new transaction to gain visibility of inbound shipments destined for FEMA Incident Support Bases (ISBs).

DLA carriers will use the DTEB 214F transaction to provide FEMA in-transit visibility. The DTEB 214F contains up to 42 event-driven status codes that provide information such as the carrier departure from the pick-up location or a shipment re-consignment (diversion). DOD carriers currently provide the DTEB 214A transaction, but USTRANSCOM developed a custom 214F specifically for FEMA support.

To ensure successful project completion, DLA will initiate communication with the appropriate parties so that transportation contracts include a requirement for carriers to implement the DTEB 214F. In the near-term, the Vendor Shipment Module (VSM) will participate in the EDI exchange with FEMA. DSS will eventually follow.
