- b. At index 2-03, the usage note for code 'VA' in B403 should be shortened to: "VA - Vessel Arrival \*\* Use 'VA' to denote vessel scheduled to arrive or has arrived. For multimodal shipments, vessel is defined as ocean vessel or aircraft."
- c. At index 2-03, the usage note for 'VD' in B403 should be shortened to: "VD - Vessel Departure

\*\* Use 'VD' to denote vessel scheduled to depart or has departed. For multimodal shipments, vessel is defined as ocean vessel or aircraft."
