**2) Old Business – Open Action Items**

- a) **AI # 2018.016** - DTEB Voting Representative Replacement
  - i) Status: **In Progress**
  - ii) New Members added since last DTEB Committee meeting.
    - (1) Ms. Teresa Farler – TPPS
    - (2) Mr. Robert Stewart (replaced Mr. Josh Hunt) – TCJ5/4.
  - iii) Next Action: Continue to add new members as they are identified.
- b) **AI # 2020.003** - Create a DM to remove two 858D Comments regarding Shipping Costs.
  - i) Status: **In Progress**
  - ii) Working with Mr. Robert Stewart TCJ5/4 to submit DM for 858D.
    - (1) Removing L1 (Position 150) Note referencing Shipping Cost
    - (2) Removing L104 comment referencing Shipping Cost
  - iii) Next Action: Support Robert Stewart in submitting the DM.
- c) **AI # 2020.004** - Add Commercial Systems on the Sync Chart
  - i) Status: **Completed**
  - ii) TPPS has been added
  - iii) DFTS has been added as an Alias to DTCI
    - (1) DFTS/3GTMS will be corrected (ITS Issue)
  - iv) Next Action: Done.
- d) **AI # 2020.007** - Determine if BLOC is still required in the DoDAAD
  - i) Status: **In Progress**
  - ii) EBSO asked the DTEB Committee membership to review and respond to Proposed Defense Logistics Enterprise Standards Change (PDC) 1389 to remove the BLOC from the DoDAAD
  - iii) SDDC G3 generates the BLOC and sends it to TRDM. TRDM stores BLOC as the Primary Key in the Lading Bill Office table. TRDM passes BLOC updates to DLA/DAAS for inclusion in the DoDAAD
  - iv) GFM non-concurred with the deletion of the BLOC from the DoDAAD
  - v) Next Action: DTEB team will schedule a meeting in April to include EBSO, SDDC, TRDM, and DTEB. We will work to discover a path to success for GBLOC.
- e) **AI # 2020.008** - Improve reporting of Estimated Delivery Date (EDD)
  - i) Status: **In Progress**
  - ii) Per EBSO on 24 Mar 21, the EBSO issued ADC 1327 solution has been completed and deployed. EBSO recommends Closure.
  - iii) Post meeting emails from TCJ5/4 recommend the Action Item remain OPEN for further analysis of EDD options in USTRANSCOM.
  - iv) Next Action: TCJ5/4 will review their needs and determine what steps are needed.
- f) **AI # 2020.009** - Harmonized Commodity Description and Coding System (HS)
  - i) Status: **In Progress**

- ii) New DM 1324 created for 858R by TCJ6 on 2021-03-30
- iii) Reason for Change: In response to the USTC Transportation Management System (TMS) Prototype Lessons Learned, the CONUS Freight Working Group must prepare for doing business like our commercial counterparts. While Air and Water Commodity Codes will continue to be used throughout the DoD, the ability to send, receive, and translate International Harmonized Commodity Classifications will become necessary. USTC TRDM already includes these Commodity Classification values.
- iv) This is the first of 13 recommended DMs to include Harmonized Commodity Classifications in the DTEB Implementation Conventions.
- v) The other 12 affected ICs: 214A, 300A, 304A, 310A, 315A, 856A, 856F, 858B, 858D, 858DA, 858E, and 858M.
- vi) Next Action: DTEB team will work with members to create the other 12 DMs required. DTEB team will recommend closure when this first (Harmonized) DM becomes the next 858R version.
- g) **AI # 2020.010** - Remove Standard Point Location Code (SPLC) from the TAC2 (SHIP TO) of the DoDAAD.
  - i) Status: **In Progress**
  - ii) Like the BLOC, DLA DAAS would like to remove the SPLC from the DoDAAD
  - iii) During the course of DLA SAP Transportation Management module discussions, SAP informed DLA that no commercial carriers were using the SPLC for calculating distance. SAP uses 5 and 9-digit zip codes.
  - iv) It was mentioned that rail transportation still uses SPLCs extensively. Formats A, C, E, G, and I of the rail Car Location Message (CLM) require a SPLC.
  - v) Next Action: Like AI # 2020.007, DTEB team will schedule a meeting in May to include EBSO, SDDC, TRDM, and DTEB. We will work to discover a path to success for SPLC.
- h) **AI # 2020.011** - Remove Break Bulk Point (BBP) from the TAC2 (SHIP TO) of the DoDAAD.
  - Status: **Completed**
  - i) DLA Distribution has requested that the Breakbulk Point (BBP) be considered for removal from the DoDAAD
  - ii) Discussions between USTRANSCOM and EBSO should follow to determine if BBP should be removed from the DoDAAD
  - iii) EBSO has not heard anything further about BBP from DLA, so we consider that matter closed at this time.
  - iv) Next Action: Done
