Security Assistance (SA)

SC Legislation & Policy

Security Assistance

- Economic & military assistance to partner nations under State
 Department authority
- Supports USG foreign policy and national security objectives
- Deliverables: Can include Defense articles, services, and training
- Terms of Transfer: Sale, grant, loan, or lease

Direct Commercial Sales (DCS)


- Administered by DoS in consultation with DoD
- Licensed by State's Directorate of Defense Trade Controls (DDTC) under the International Traffic in Arms Regulations (ITAR)
- Export licenses normally valid for a four year period...and sales may/may not occur
- Generally paid for with partner funding this program does not include an appropriation
- Approved FY21 DCS transfers ≈ \$103.4 B



Economic Support Fund (ESF)

- Administered by USAID
- Provides funding assistance as determined by Secretary of State to countries/organizations to promote economic or political stability
 - Energy independence
 - Economic growth
 - Education
 - Health care
- \$4.1 B








International Narcotics Control and Law Enforcement (INCLE)

- Administered by DoS/INL
- Provides funding assistance to countries and international organizations for the control of narcotic and psychotropic drugs and other controlled substances, and for other anticrime purposes
- \$1.46 B

Nonproliferation, Anti-terrorism, Demining, and Related (NADR) Programs

- Administered by DoS/ISN
- Authorizes funding assistance to countries/ organizations to enhance law enforcement personnel in deterring terrorists and halting the proliferation of chemical, nuclear, biological, and conventional weaponry
- \$900 M





Peacekeeping Operations (PKO)

- Administered by DoS/PM
- Authorizes funding assistance to friendly countries/international organizations for peacekeeping operations and related programs
- Past efforts have trained over 100,000 peacekeepers from 38 countries
- Current emphasis is on increasing partner long-term sustainment capabilities
- \$463 M; of which \$71 M Global Peace Operations Initiative (GPOI)

Foreign Military Sales (FMS)

- Administered by DoD/DSCA using the FMS LOA process, under continuous supervision and general direction of State/PM/RSAT
- Permits transfers via sales and leases of:
 - DoD/USCG inventory = stock
 - DoD procurement = new acquisition from U.S. contractors
 - DoD or U.S. contractor-provided training
 - DoD military design/construction services
- FY21 (implemented cases) ≈ \$28.67B



Foreign Military Financing (FMF)

- Administered by DoD/DSCA in consultation with DoS/PM and USD(C)
- Supports transfers via USG grants and loans to foreign partners
 - Normally used to fund FMS cases
 - Can be used in very limited situations to fund DCS purchases by select countries
- \$6.057 B

International Military Education & Training (IMET)

- Administered by DoD/DSCA in consultation with DoS/PM
- Military training to foreign military/civilian personnel on a grant basis Appropriated to the President and allocated by DoS
 - Can occur in the United States or (with a waiver) overseas
 - Includes the Expanded IMET (E-IMET) subprogram
- Purpose:
 - To transfer military skills and knowledge
 - To enhance U.S. partner interoperability
 - To expose partners to democratic values and human rights
- \$113M

Excess Defense Articles (EDA)

- Administered by DoD/DSCA, under continuous supervision general direction of DoS PM/RSAT
- Transfers of excess U.S. stock items via FMS process
 - Articles can be sold at a reduced price (§21, AECA) or via grant transfers (§516, FAA)
 - "As is-where is" principle applies to EDA transfers



Security Cooperation

Title 10, USC

DoD Objectives (The ABCs)

- Gain <u>Access</u> overflight/landing, coastal/port or overland access to move personnel and equipment, or for refueling or resupply enroute
- **Build** Relationships for potential engagement and participation in future peacekeeping or conflict operations (or not to interfere with them)
- Develop/Enhance <u>Capabilities</u> ensure partner nation has training and equipment to defend itself or to participate in PKO or conflict operations



Security Cooperation Definition

The term "security cooperation programs and activities of the Department of Defense" means any program, activity (including an exercise), or interaction of the Department of Defense with the security establishment of a foreign country to achieve a purpose as follows:

- To **build and develop allied and friendly security capabilities** for self-defense and multinational operations.
- To provide the armed forces with <u>access</u> to the foreign country during peacetime or a contingency operation.
- To <u>build relationships</u> that <u>promote specific United States security</u> interests.

Coordinate technology transfer decisions

 Provide defense articles, services, and training to partner nations

 Participate in international armaments cooperation

Title 10 U.S.C., "Train & Equip" Or Capacity Building

- Several programs administered by DSCA, coordinated with DoS, and notified to Congress
- DoD provides material assistance and related tactical/operational training to partner countries to develop specific defense capabilities
 - Executed via a "pseudo" LOA process that produces building partner capacity (BPC) LOAs
 - Authorities (and sometimes funding) are provided through many different programs (refer to DSCU SC Programs Handbook)















Definitions

 Shipper: The DoD depot (MILDEP, Defense Logistics Agency (DLA), Defense Contract Management Agency (DCMA), or commercial contractor or suppliers under DoD contract

 Carrier: The trucking company, rail company or barge that moves the material from the shipper to the port, to the freight forwarder, or to the final destination under DTS or freight forwarder contract

 Freight Forwarder: The commercial import/export company hired by the FMS customer to arrange transportation of material to, from or within the US

IPTN-201 - INTERNATIONAL PARTNER SECURITY COOP LOGISTICS & FINANCE

This course is divided into three primary areas covered within the context of a Security Cooperation (SC) relationship with the U.S.

- 1. Overview of legislation and policy; planning, programming, and budgeting; resource management; technology transfer and export controls; SC process; and acquisition and contract administration.
- 2.Logistics management, including initial support, sustainment, transportation, requisitioning, and discrepancy reports.
- 3. Financial management, including funds management, pricing policies, and billing procedures.

Personnel in defense ministries, service headquarters, procurement bureaus, international liaison personnel assigned to U.S. organizations, as well as defense attachés and foreign procurement officials assigned to Washington, D.C.




