LEGISLATIVE ANALYSIS

Vacancies, Nominations and Confirmations: The seven month era of an acting SECDEF has ended as Sec Mark Esper was confirmed 90-8 by the Senate. His confirmation ended a vacancy dating back to 31 December, 2018 when Sec Mattis resigned. Sec Esper stated that one of his first priorities will be to fill the current leadership vacancies within DoD. However, while one vital position is filled, a subsequent cascade of openings may in turn be created. In an even more resounding vote, GEN Mark Milley was confirmed 89-1 as the new chairman of the Joint Chiefs of Staff.

After initial uncertainty, Sen Inhofe stated that Gen Hyten will have a nomination hearing as Vice Chair of the Joint Chiefs of Staff. The open hearing will take place on 30 Jul with the implication of having a far less clear nomination process than Sec Esper and GEN Milley. Also of note, Gen Selva is due to retire creating an even more pressing need to fill the position. If not, his retirement may be postponed or an acting Vice Chair may be instituted. The Hon Norquist, who recently visited with GEN Lyons at Scott AFB, completed his hearing on 24 Jul to be the Deputy SECDEF and is awaiting a final confirmation vote in the Senate. If confirmed, this will allow Richard Spencer, who is the current acting Deputy SECDEF, to return as SECNAV.

National Defense Authorization Act (NDAA): The House voted strictly along party lines and passed their version of the NDAA on 12 July. Their version is \$17 billion less than the President's \$750 billion request which is mirrored by the Senate version. The key differences between the chambers are requiring congressional approval for military action against Iran, and increased funding for a border wall. Prior to passage in the House, an amendment brought by Rep Matt Gaetz (R-FL) and Ro Khanna (D-CA) passed which restricted funding for military force unless Congress approved it. Additionally, it also stipulated the 2001 AUMF does not apply to Iran. This consensus is in contrast to the Senate version which places fewer restrictions on presidential authority to take action against Iran if required. The next step is the NDAA Conference which is being planned to take place in late-September in order to agree on a final version.

HAPPENINGS ON THE HILL:

- During the SECDEF nomination hearing, Sen Duckworth (D-IL) asked Sec Esper to commit to paying closer attention to our logistical needs to include funding for sealift, airlift and other aspects of our logistics infrastructure which also include amphibious shipping for the Marine Corps. Sec. Esper concurred. He further shared with the audience that sealift moves about 90% of the Army's cargo to the fight and that we need to modernize and build capacity with regard to sealift.
- Sen Shaheen (D-NH) stated that GEN Lyons indicated the Air Force was making preparations to push back the retirement of 28 legacy tankers causing the Senator to express concern of the cost associated with this decision. She asked Sec Esper to commit to a review of the KC-46 program and the second and third order effects that are now being seen as a result of these delays. Sec Esper acknowledged that AMC recently wrote her a letter committing that the billets would not be moved and in due course, actually will increase the number of billets. He concluded his answer with telling the Senator that he needed to work with her on "the timing in which those aircraft will return to Pease".
