### **ENVIRONMENT ON THE HILL:**

Despite sexual assault and harassment issues and investigations into Russia's involvement in the election consuming much of Congress's attention; Republican were able to finalize a tax reform bill expected to pass and be signed by the President this week.

The bad news is there will be little time for them to celebrate with the rapidly approaching deadline for action before the expiration of the second Continuing Resolution (CR) on 22 December. Anything other than another





CR into January seems unlikely. Attempts for full-year DoD funding and a CR for everything else will meet strong opposition in the Senate and could set up a fight leading to a government shutdown.

The DoD has long criticized the negative impacts on military readiness and long term programs of CRs. Secretary of the Navy, Richard Spence recently stated that CRs have cost the Navy "enough to buy a squadron of F-35 Joint Strike Fighter aircraft." He went on to say "*Since 2011, we have put \$4 billion in a trash can, put lighter fluid on top of it and burned it.*"

The Center for a New American Security recently published a report <u>("A Brief History of Defense Budget Instability"</u>) on the impacts of CR on the DoD.

"... Department of Defense (DoD) has lurched from one budgetary crisis to another for nearly a decade." "This defense budgetary instability is national self-harm on an epic scale."

# The National Defense Authorization Act (NDAA):

Signed, sealed, and delivered -- the President signed the NDAA (<u>H.R. 2810</u>) on 12 December. He also release a "<u>Signing Statement</u>" in which he objected to parts of the NDAA. The \$700B authorization act far exceeds the Budget Control Act's FY2018 limit of \$549B for the DoD.

**Appropriations:** Still conferencing... However, House Republicans recently indicated they are considering a defense bill to fund the DoD for FY2018 and fund everything else through 19 Jan 2018

in a third CR. Senate Democrats are not expected to support this as they would lose leverage for nondefense spending (proportional increases/relief from the BCA limits).

### Tax Bill:

Republicans agreed on language in the Tax Cuts and Jobs Act (H.T. 1) – The House vote is expected on Tuesday followed quickly by the Senate; then to the President this week. Here are <u>Highlights</u>; and the full document (<u>Tax Cuts and Jobs Act</u>).







### **GAO report to Congress** - <u>EUROPEAN REASSURANCE INITIATIVE</u> -DOD Needs to Prioritize Posture Initiatives and Plan for and Report Their Future Cost

"From fiscal year 2015 through fiscal year 2017, the Department of Defense (DOD) identified \$5.2 billion in funding for ERI as part of its overseas contingency operation (OCO) budget requests.2 Most of this funding would be used to enhance posture—forces, footprint (locations and infrastructure), and host nation agreements—in Europe by funding increases in military presence, improving infrastructure, and prepositioning equipment."

**CRS -** <u>Coast Guard Polar Icebreaker Modernization</u>: Background and Issues for Congress Vice Admiral Charles Michel ..."Polar icebreakers are critical to supporting key national priorities laid out in the National Security Presidential Directive on Arctic Region policy and the National Strategy for the Arctic Region." "Coast Guard needs at least two heavy icebreakers to provide year-round assured access and self-rescueability in the polar regions."





### **CBO** - Analysis of the Long-Term Costs of the Administration's Goals for the Military

CBO estimates that inflation-adjusted costs for the Department of Defense would climb from the \$575 billion requested in 2018 to \$688 billion in 2027 if DoD pursued goals that Administration officials have articulated for the military.

"Because defenses against cyber intrusion and attack are not perfect, and the spread of offensive capabilities cannot be blocked with confidence, states and major private enterprises must invest in resiliency." "Resiliency will mean and require different things in different contexts—that is,

in the military, the financial sector, the energy sector, and so on."



Congressional Budget Office (CBO) report – "<u>Federal Debt and the Statutory Limit,</u> <u>November 2017</u>"

"Under current law, on December 9, federal debt will be at the statutory limit and the Treasury will need to use "extraordinary measures" to continue to raise cash. Those measures would probably be exhausted in late March or early April."
