**Subject:** Roll-Out of 2022 DP3 HHG Business Rule Changes Training

1. The DPMO developed familiarization training to inform Defense Personal Property personnel on the changes made to the HHG business rules for the 2022 moving season. The updated set of rules impacts all shipments that move on and after May 15, 2022. This course is to provide transportation practitioners a preview of changes well before they go into effect with the goal to lessen the stress policy changes often cause and minimize delays and frustrations for customers.
