To: Military Service Headquarters Representatives, Worldwide Personal Property Shipping Offices (PPSO), Personal Property Processing Offices (PPPO), and DoD-Approved Personal Property Transportation Service Providers (TSP)

Subject: Rescind of USTRANSCOM PP Advisory #20-0094, due to postponement of temporary closure of the Air Mobility Command (AMC) Norfolk Military Air Terminal (MAT) from 1 August until 30 November 2020. The Norfolk temporary closure has been postponed until March 2021.

Purpose: With the postponement, the Aerial Port of Embark (APOE) for Code of Service (COS) J/T and DPM destined to Bahrain (BAH), Djibouti (JIB), Guantanamo Bay, Cuba (NBW); Kingston, Jamaica (KIN), Naples, Italy (NAP), Rota, Spain (RTA), Sigonella, Italy (SIG) and Souda Bay, Greece (CHQ). will need to be routed to Norfolk MAT for AMC channel airlift.

1. AMC has advised the Norfolk flight line construction project has been postponed until March of 2021. We will accomplish another advisory for that time period when the dates of closure are finalized.

2. PPPO/PPSO; Immediately begin selecting the POE of NGU when routing Code J/T and DPM shipments to the PODs of; Bahrain (BAH), Djibouti (JIB), Guantanamo Bay, Cuba (NBW); Kingston, Jamaica (KIN), Naples, Italy (NAP), Rota, Spain (RTA), Sigonella, Italy (SIG) and Souda Bay, Greece (CHQ).

3. TSPs/origin agents, with the postponement of alternate POE of JB Charleston, ALL Code J/T and DPM shipments destined to Bahrain (BAH), Djibouti (JIB), Guantanamo Bay, Cuba (NBW); Kingston, Jamaica (KIN), Naples, Italy (NAP), Rota, Spain (RTA), Sigonella, Italy (SIG) and Souda Bay, Greece (CHQ) will now need to be directed for delivery to the AMC Norfolk MAT.

3.1 As the PPPO/PPSO were advised 19 Jun to select the POE of Charleston-CHS, we do realize there will be shipments serviced with that POE on the two-dimensional military shipping label (2DMSL) and Transportation Control and Movement Document (TCMD). We request you make pen/ink changes on the 2DMSL and TCMD to POE-NGU and deliver all to the Norfolk MAT.
