Zone 1 – San Diego County (Northern Half) in the state of CA

Zone 2 – From the metropolitan area of Beaumont on an imaginary line due North to Hwy 38. Hwy 38 North to Big Bear City where it intersects with Hwy 18. From this intersection, Hwy 18 West to the intersection of Hwy 138 (near Crestline). From this intersection, Hwy 138 North, then West to its intersection with Hwy 15. From this intersection, Hwy 15 South to the point where it leaves the Cucamonga Wilderness area of the San Bernardino National Forest, to the San Bernardino County line. From this point to the San Bernardino County line South to the intersection with Hwy 71, following The San Bernardino County line South to its intersection with Hwy 74 (to include the metropolitan area of Elsignore). From this intersection, Hwy 74 Northwedd to Perris (to include the metropolitan area of Perris), then East to its intersection with Hwy 74 (to include the metropolitan area of Hemet). From this intersection, Hwy 79 North to Beaumont.

Zone 3 – Orange County South by Southwest of Interstate 55 and South by Southwest of Interstate 91. Except the metropolitan areas of Newport Beach, Costa Mesa, Orange, Santa Ana, Tustin, and Anaheim, which are the responsibility of Seal Beach Detachment, CA
