## OTHER DEPARTMENT OF DEFENSE (DOD) AND UNITED STATES (U.S.) GOVERNMENT AGENCIES' TRANSPORTATION ACCOUNT CODES (TAC)

## A. GENERAL

TACs are used to identify the appropriation or user ultimately responsible for paying the transportation costs incurred for the movement of material within the Defense Transportation System between the continental United States (CONUS) and outside the CONUS (OCONUS) and for onward movement to the final OCONUS destination. The source for determining valid TACs is the Transportation Global Edit Table (TGET) on the World Wide Web (WWW). Go to Internet address <u>https://beis.csd.disa.mil/beis-html/frontpage-pki.html</u> and select "TGET Web - Transportation Global Edit Table."

**NOTE**: First-time users must obtain a username and password by selecting "First-Time Users Click Here."

- 2. A search can be initiated on the TGET by either the TAC assigned to a shipment or by descriptive words that would be found in the Description field on the TGET. A POC should be listed for each TAC to provide assistance in the proper use of the TAC.
- 3. Invalid TACs. Vendors, contractors, and other shippers of other DoD and U.S. Government Agency material will validate every TAC prior to creating shipment documentation. A TAC is valid only if it is loaded in the TAC database on the WWW. Aerial and seaport operators will validate TACs per the procedures outlined in Appendix V.
- 4. Non-DoD and U.S. Government Agency TAC Coordination/Assistance. The following TAC coordinator has been established to provide assistance in TAC assignment issues: <u>dfas.indianapolis-in.jja.mbx.tac-requests@mail.mil</u>.
- 5. Billing Information. Billing will be made in accordance with the billing instructions contained in the TGET.
